1. Valid for a period not less than 120 days after the deadline specified for submission of bids.

2. Fabrication of Laboratory Work Table with validity for one year in the Department of Agronomy, College of Agriculture, Tripura.

3. Only technically successful bidders are allowed for financial bid opening.

**SECTION-B****GENERAL TERMS & CONDITIONS FOR Fabrication of Laboratory worktable at Department of Agronomy, CAT, Lembucherra, West Tripura.**

1. The Bidder should have valid License. The Bidder should have a valid PAN Card, GST Registration (certificate need to be furnished). The bidder must have filed its Income Tax Returns for the last 3 (three) Financial Years. Copy of Income Tax Returns for the last 3 (three) Financial Years need to be furnished.
2. **TENDER FEE:**
  - a) The participating bidders **must pay an amount of Rs. 500/- (Rupees five hundred only) as Tender Fee** paid online in SBI AC No-36420611563, IFSC-SBIN0016016. The details of online payment must be submitted.
  - b) **The Tender Fee (TF) that will be paid is Non-Refundable.** For exempting tender fee, appropriate Govt. order should be included in the technical bid.
3. Up-to date clearance certificate of Income Tax, GST etc. is to be submitted failing which the tender shall be treated as invalid and rejected.
4. **Tender submission by hand only to the office of Principal, College of Agriculture, Tripura, Agartala, P.O. Lembucherra-799210, West Tripura on or before 13.04.2026 01:00PM.** Tenders received after the due date and time shall not be considered under any circumstances.

**5. AWARD OF CONTRACT:**

- a) Technically successful bidders are allowed for financial bid evaluation. Financially L1 bidder is allowed to execute the work as per specification specified at Section-D of this NIQ.
- b) Failure to complete the work as specified in Section-D, (1) **within 15 days after receiving the work order**, shall entail forfeiture of the Security deposit. Under special circumstances the period for supply of materials may be extended.
- c) The written agreement between the bidder and the Principal, College of Agriculture, Tripura shall be the foundation of the rights and obligations to both the parties. The contract shall not be deemed to be complete until the agreement has first been signed by the bidder and then by the Principal, College of Agriculture, Tripura. **The contract or is responsible for repairing any damage without any extra fund from college within 3 years after completion of the work.**

6. The tender is valid for a period of one (1) year from the date of work order, which can be extended further on mutual agreement as per the existing terms and conditions. The College also reserves the right to terminate the contract at any time during the contract period by giving 30 days notice to the Bidder.

**7. MODE OF SUBMISSION OF BIDS:**

i) Separate submission of Technical and Financial bids with in the mentioned period, published in the Newspaper.

ii) The Bidder shall follow 'Instruction to Bidders' in Section C.

iii) The Bidder shall examine all instructions, forms, terms and specifications in the Bid Documents. Failure to furnish all information required as per the Bid Documents or submission of bids not substantially responsive to the Bid Documents in every respect will be at the bidder's risk and may result in rejection of the bid.

8. Before the last date for submission of Bids, the Bid Inviting officer may modify any of the Contents of the Bid Notice, Bid documents by issuing amendment/ Addendum/ corrigendum.

9. Any addendum/ amendments/ corrigendum issued by the bid Inviting officer shall be part of the bid Document and it shall be published in <http://coatripura.ac.in/>. However, College of Agriculture, Tripura, shall bear no responsibility or liability arising out of non-receipt of the same in time or otherwise. Bidders are requested to visit the website frequently to check whether there is any related Corrigendum(s) or not.

10. To give prospective Bidders reasonable time to take an addendum / amendments / corrigendum into account in preparing their bids, the Bid Inviting Officer may extend, if necessary, the last date for submission of the bid.

11. During the above-mentioned period, no plea by the bidder for any sort of modification of the bid based upon/arising out of any alleged misunderstanding / misconceptions / mistake or any reason will be entertained.

**12. Payment:**

i) On successful completion of the work, bidder should place the corrected GST bill within 7 days for settlement. Final settlement of bill(s) is subject to availability of funds in College account (usually within 45 days after submission of bills).

ii) **Every participating supplier/contractor has to mandatorily disclose the bank account number which is linked with the GSTIN at the time of Bid submission. No payment shall be released by the government department/agency to any other bank account except the one linked with the GST registered number of the successful bidder.**

iii) College will deduct IT and GST as per applicable rules of government guidelines.

iv) No advance payment shall be made including payments of handling charges/ service charges/ GST charges etc. under any circumstances to the bidder.

v) All remittance charges will be borne by the bidder.

vi) In case the bidder fails to execute the bidder, College of Agriculture, Tripura shall have liberty to get it done through any other agency with full cost recoverable from the bidder in addition to damages and penalty.

**13. BID OPENING**

i) The technical Bid(s) will be opened at **03.00 PM on 13.04.2026**.

ii) In case of any un-scheduled holiday (s) or occurrence of some event beyond control of the bid inviting authority on the day of opening, the NIQ will be opened on the next working day at the same time.

v) Once the Technical Bid(s) accepted, the Financial Bids of the vendors (whose Technical Bids has been accepted) shall be opened. College authority reserves the technical and financial bid evaluation report as legal documents and circulates on official demand/instructions only.

vi) In case of any ambiguity, the decision taken by Bid Acceptance Authority on bids shall be final.

#### 14. EVALUATION OF TECHNICAL & FINANCIAL BID

The purchaser will evaluate and compare the tenders determined to be substantially responsive i.e. which:

- a) Are properly signed and
- b) Conform to the terms and conditions and specifications

15. In the event of breach/violation or contravention of any terms and conditions contained here in by the agency i.e., if the Firm fails to execute the contract, the submitted security deposit, part / whole (as per decision of Principal, College of Agriculture, Tripura), will be forfeited from the guarantor.

#### 16. AWARD OF CONTRACT

- i) Principal & Director, College of Agriculture, Tripura will award the contract to the qualified bidder.
- ii) The written agreement between the bidder and the Principal, College of Agriculture, Tripura shall be the foundation of the rights and obligations to both the parties. The contract shall not be deemed to be complete until the agreement has first been signed by the bidder and then by the Principal, College of Agriculture, Tripura.

#### 17. CORRUPT OR FRAUDULENT PRACTICES

The Government requires that the bidders/service providers under Government financed contracts observe the highest standard of ethics during the procurement and execution of such contracts. In pursuance of this policy, the Government defines the terms set forth below as follows:

- i) "Corrupt practices" means the offering, giving, receiving or soliciting of anything of value to influence the action of a Government official in procurement processor in contract execution and "Fraudulent practice" means a misrepresentation of facts in order to influence a procurement processor the execution of a contract to the detriment of the Government and includes collusive practice among bidders (prior to or after bid submission) designed to establish bid prices at artificial non-competitive levels and to deprive the Government of the benefits of free and open competition.
- ii) Government will reject a proposal for award if it determines that the bidder recommended for award has engaged in corrupt or fraudulent practices in competing for the contract in question.
- iii) Government will blacklist/or debar an individual Service Provider/firm/organization, either indefinitely or for a stated period of time, if at any time determines that the firm has engaged in corrupt or fraudulent practices in competing for, or in executing a Government Contract.

College of Agriculture, Tripura reserves the right to accept or reject any Bid or all Bids and to cancel the Bidding process, at any time prior to the award of Contract, without thereby incurring any liability to the affected bidder or bidders or any obligation to inform the affected bidder or bidders of the reasons for such action.

#### 20. ARBITRATION:

The resultant contract will be interpreted under Indian Laws. Any legal disputes arising out of this are subject to jurisdiction of Agartala only.
